TO ASSIST IN PROTECTION OF ENDANGERED FLORIDA PANTHER**

NAPLES, FL. September 27 – Andrew Hill Investment Advisors, Inc. (AHIA), a Naples-based investment and wealth management advisory firm, announced that it has partnered with the Florida Panthers Foundation, the main charitable beneficiary of the Florida Panthers National Hockey League team, on a new outreach program to help raise awareness and funds to assist in conservation efforts for the endangered Florida panther.

Panthers once roamed throughout the southeastern United States, but today their range is limited to South Florida (less than 5 percent of what it once was). With an estimated population of only 120 to 160 panthers remaining in the wild, the Florida panther is one of the most endangered mammals in the United States. The Florida Panther National Wildlife Refuge protects more than 26,400 acres of panther habitat in Collier County.
